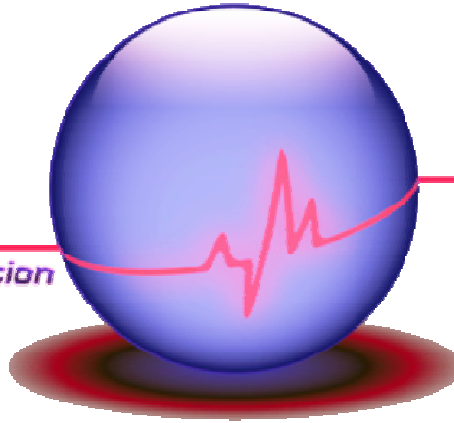

POSTSECONDARY PROGRAM INFORMATION

EMERGENCY MEDICAL TECHNICIAN

EMT COURSE APPROVALS

Fast Response's EMT Program is approved to operate by:

- California Bureau for Private Postsecondary Education (BPPE);
- California Emergency Medical Services Authority (EMSA);
- Alameda County EMS Agency (ALCO EMSA);
- National Registry of Emergency Medical Technicians (NREMT).



EMT COURSE HOURS AND SCHEDULE

Course hour outline:

- 5 hours – American Heart Association Healthcare Provider CPR
- 168 hours – In class didactic and laboratory instruction and practice
 - EMT Foundations – 40 hours
 - Medical Emergencies – 40 hours
 - Trauma Emergencies – 40 hours
 - Specialties – 40 hours
 - Cumulative final – 8 hours
- 8 hours – Emergency Department externship
- 10 hours – Ambulance externship

Program schedules:

- Full-Time Program
 - The full-time program will usually meet 8:30 am – 5:00 pm, Tuesday through Friday.
 - Length – 6 weeks total
 - 5 weeks - classroom attendance
 - 1 week (two independent days) externship
- Part-Time Program
 - The part-time program will usually meet nightly from 6:00 pm – 10:00 pm on Monday, Tuesday, and Thursday and from 8:30 am – 5:00 pm on Saturday.
 - Length – 10 weeks total
 - 9 weeks - classroom attendance
 - 1 week (two independent days) externship

EMT PROGRAM COST

EMT Program Fees and Tuition:

- \$250.00 - Registration Fee
- \$200.00 - Background Check
- \$200.00 - Insurance
- \$204.18 - Textbooks
- \$5.00 - Uniform Patches
- \$1440.14 - Tuition
- \$5.00 - Student Tuition Recovery Fund (STRF)
- **\$2304.32** – Total Program Cost

PAYMENT OPTIONS

Fast Response School of Health Care Education helps eligible students seek financial assistance. The School offers payment plans to accommodate the tuition and fees incurred by attending courses at the School.

Payment Plan 1 (PP1):

- Due at enrollment: \$250.00 + STRF + Patch Fee (EMT)
- Due prior to course: Remaining fees and tuition

Payment Plan 2 (PP2):

- Due at enrollment: \$250.00 + STRF + Patch Fee (EMT)
- Due prior to course: All remaining fees, less tuition
- Due in installments: Tuition – to be paid off before expected graduation date

Payment Plan 3 (PP3):

- Due at enrollment: \$250.00 + STRF + Patch Fee (EMT)
- Due prior to course: All remaining fees, less tuition
- Due in installments: Tuition – to be paid off within three (3) months after expected graduation date
- **Note: Student will not receive a certificate of course completion until payment-in-full is complete.**

EMT FACILITIES AND EQUIPMENT

Didactic (Classroom) Training:

- Provided in a classroom outfitted with laptop and three (3) flat-screen LCD televisions.

Psychomotor (Skills) Training:

- Provided in a large warehouse-type setting located away from the classroom equipped with:
 - Rebuilt patient compartment of an ambulance
 - Three EMS patient gurneys
 - Two hospital beds
 - Mock apartment setup



EMT ADMISSIONS PROCEDURE

Admission to postsecondary programs follows these steps:

- Provide evidence of meeting the program's minimum standards:
 - Proof of legal residency;
 - Minimum age of 18 on the first day of class. Minors – enrollment and financial agreement must be signed by parent or guardian;
 - High School Diploma or GED (Must furnish document or transcripts).
- Attestation of personal background information;
- Successful completion of an entrance examination (Wonderlic) with a score of 16 or greater;
- Completion of an enrollment agreement;
- Completion of a financial agreement;
- Financial plan for funding education;
- Payment either in full or of the first required installment of a payment plan.
